## Shipping Guidelines for International Exhibitors

GlobeX Logistics has been appointed by Champion Shipping Services to assist international exhibitors with shipping to and from the show. GlobeX offers:

- Export customs clearance
- Local pick-up, air, sea and ground transportation
- U.S. customs clearance and posting of customs bonds

### Consignment Instructions:

The first step in ensuring customs clearance is to consign your shipment properly. Shipments consigned directly to the exhibition center, or to Champion, are likely to be rejected by U.S. Customs. It is important to consign your shipment to GlobeX at this address.

### Deadlines for Arrival:

In order to clear U.S. customs, it is essential to allow enough time for your shipment to be processed. Please stick to the following timeline:

| Sea Freight—Less than Container Loads (LCL): | 20 Business days prior to desired delivery |
| Sea Freight—Full Container Loads:            | 15 Business days prior to desired delivery |
| Air Freight Services:                        | 10 Business days prior to desired delivery |

### Documentation/Pre-Alerts:

GlobeX requires a full set of shipping documents, including a commercial invoice and packing list, or ATA Carnets, prior to your shipment's arrival. Failure to do so may cause delays and additional expenses. Documents may either be faxed to +1-702-433-2948 or e-mailed to [twarren@globexlogistics.net](mailto:twarren@globexlogistics.net).

### Shipments by Sea:

U.S. Customs and the Transportation Security Administration have implemented new rules regarding the import of materials by sea. Shipments arriving into a U.S. port by sea must first have an Import Security Filing 72 hours prior to cargo loading. Therefore, all documents must be sent to GlobeX Logistics at least 120 hours prior to scheduled loading on board any vessel destined for the U.S. Failure to do so will result in penalties starting at \$5,000. Shipments sent without ISF Filing will not be cleared by GlobeX Logistics.

### Federal Tax ID:

In order to clear U.S. customs, all shipments require a Federal Tax ID number. The customs broker is required to provide a Federal Tax ID number for the importer or end user of the merchandise. Your shipment will fall into one of the following categories:

- Use GlobeX as your customs broker—the company will allow you to use their Tax ID number
- Use your own qualified broker—use the broker's ID number. If the broker does not have a Tax ID number, contact the show venue and ask to use its Tax ID number

Please note that Champion is not able to provide you with its Tax ID number for use in clearing customs.

### Restricted Articles:

The U.S. restricts the shipping of some items, including food products, alcoholic beverages, animal by-products, military articles and some medical devices. To see if your shipment will be impacted, contact us for a full list of restricted items.

### List of Agents:

Upon request, we can provide you a referral to a local transport company in your country who specializes in exhibition freight forwarding.
